Dundas & Wilson is a top 40 UK law firm with offices in London, Edinburgh and Glasgow. It is the largest Law firm in Scotland with over 600 employees. The firm services a wide range of clients, including major commercial companies and public sector organisations throughout the UK and abroad.

The firm relies on the Internet and it is used extensively for email, client extranets, researching clients and prospects, personal use and online legal research tools.

Although as an organisation it had not come face-to-face with malware, it recognised the importance of having a Web security solution in place that would give it 100% confidence its network and employees were protected.

The Challenge

Dundas & Wilson previously used Smartfilter for its Web filtering and MessageLabs for Web scanning.

“We were experiencing problems with our Web scanning solution and found we were having to bypass the solution to get access to various Websites on a regular basis,” comments Billy Kirkwood, Head of IT Shared Services at Dundas & Wilson.

Dundas & Wilson launched the service in September, 2009 for 600 users. They are also on the beta version of ScanSafe's new Web Intelligence Reporting (WIRe) tool.
